



General Information: A General Information (GI) form will be supplied by Forest Lodge and is required to be filled out and returned to Forest Lodge 10 days prior to your organizations event.

Should you expect your group to exceed your minimum guarantee, we are to be notified in writing per the General Information. The new figure will then become your final guarantee and the minimum number of persons for which you will be charged.

Should your actual gate count exceed your guaranteed minimum, you will be invoiced for the actual number of Adults & Children that attended the event.

Payment Requirements & Interest: It is required that full payment of the contracted amount be made 7 days prior to the date of your event,

If any payment due under this agreement is delayed for any reason, including, without limitation, as a result of any fee under payment, interest shall accrue and be payable, to the extent legally enforceable, on such unpaid principal amounts from and after the date on which the same became due, at the rate of 1.5 % per month.

Deposit Schedule: To firmly reserve the above-mentioned date, your initial deposit and a signed copy of this contract must be submitted on, or before your first deposit due date (schedule above.) A second deposit must be submitted on, or before scheduled date (schedule above.) Failure to comply will constitute immediate cancellation without further notice to you. Deposits are non-refundable.

Infringement: This contract is binding when signed and the aforesaid date has been reserved for you. In the event you breach this agreement by cancellation or otherwise for any reason, Forest Lodge will be entitled to retain the deposit plus reimbursement for all losses and damages sustained from said breach.

Admission & Tickets: To gain admission to Forest Lodge all guests must have a licket. If tickets are not supplied, Forest Lodge will take a head count at the gate and the total count tallied will be what you are invoiced for, which may not be less than your minimum guarantee. If using a ticket, it must designate whether it is for an adult or child (4-1) years of age only). Tickets are supplied and distributed by your organization to each eligible guest prior to entrance to Forest Lodge.

Supply Conditions & Marketing: We reserve the right to make substitutions if necessitated by supply conditions. Forest Lodge reserves the right to use photos taken during events for marketing purposes, exceptions can be made.

Force Majeure: The lessor shall not be responsible for any breach of this contract, or similar inability to perform, arising from any matter beyond the control of the lessor, including acts of God or nature; further, the Lessor shall not be responsible for any damages to Lessee property that arises from matters beyond the control of the lessor or caused by acts of God or nature.

If a mandatory, federal, state, or local government directive prevents the Forest Lodge from performing under the terms of this contract, including COVID-19 restrictions, the initial deposit, and any additional monies paid shall be applied to a mutually agreed upon future date without penalty within 12 months of your original contracted date. No refunds will be applied.

FOR ALL SCHOOL EVENTS: Chaperones: The district agrees to provide chaperones for the event. The chaperones will monitor student behavior including any alcoholic beverage or drug consumption by minors. Forest Lodge reserves the right to remove any and all guests whose behavior endangers the bealth and safety of any other person. The district agrees to provide professional security at their own expense. Forest Lodge reserves the right to review and must agree to the districts selection.

Insurance: Due to local noise ordinances and insurance specifications, Forest Lodge will not permit any disc jockeys or other outside contractors unless preapproved in writing by Forest Lodge. All alcoholic beverages must be purchased from Forest Lodge, liquor is not permitted to be brought into the facility. No minors will be served. Buses must park in designated areas. All recreational games must be played on designated fields. All guests must have some form of company identification or ticket for entrance into the facility. No coolers or large plastic water bottles will be permitted. No animals are allowed on the property. Identifiable service animals will be permitted with prior notification to Forest Lodge. No roller blades, skate boards or scooters or any similar items are allowed on premise; Any activities being conducted on site are to the sole discretion of Forest Lodge.

Payments: Deposits and final payments can be made by company check. Make check payable to Forest Lodge LLC. Any payments made by credit card will be subjected to a 3% convenience fee. Wire transfer can be called in and handled by our office manager personnel.
