Organization History

The Lights On! Program has been an active recreation and social/emotional learning program operating at West Side High School for 5 consecutive years. The program was funded with grants. Lights On! continued to operate during COVID battling hunger.

Program Proposal

The Lights On! Program implements the whole child philosophy which involves cultivating relationships with students, community, and partner stakeholders. The program impacts student academic achievement, while simultaneously eliminating barriers to learning and growth. The program factors in that student learning can be limited because of barriers that are non-academic. Removal of barriers while nurturing relationships corresponds to growth for underperforming subgroups of students and the general population. The target grade band is students in grades 7-12. The adult/youth participant ratio is 1:25.

The Lights On! program believes that students are more likely to succeed in academics when they attend a school or live in a community with positive climate and culture. The program operates under the philosophy that it is the responsibility of all adults within the community to intentionally focus on creating an environment that is welcoming and where youth feel a sense of belonging and connectedness. Both general education and special education students/youth attend the program.

Lights On! has been implemented at West Side High School and has proven to engage students, battle hunger, enhance youth social-emotional skills, build community, increase safety, and reduce crime. The students that attend Lights On! from West Side High School have improved their discipline by building relationships with the human capital in the program. The program accepts students within the community which can impact enrollment at West Side.

Implementing this program in schools throughout the district will greatly benefit the students of Newark, increase community stakeholder buy-in and the further reduction in crime.

- Collaborate with governing bodies to obtain approvals to provide custodians and security for the program calendar.
- Obtain permits for the program.
- Draft and approve liability waivers for all youth participants in Lights On program.
- Meet with Police Department -
 - A. Ensure safe passages to and from the facility during the program time.
 - B. Obtain a patrol within the vicinity of the facilities building while the program is active
- Work with school-based principal or designee to identify and hire human capital with talents that can be implemented in the Lights On Program. Hire staff that consist of community stakeholders or members vested in the community that have a pulse on the street activities to prevent external factors from corrupting the program. *The talents of the human capital will dictate what activities will be put in place for the duration of the program.
- Identify staff that will conduct walk-throughs of Lights On at the designated premises.
- Identify a safe space for the program within the selected school facility.
